4. **HOW TO ENTER THE PROMOTION:** To be eligible to participate in the draw in respect of the given prize, the entrant ("Entrant") must comment below the blog post and include the answer to the set question: "What fancy dress costume would you wear to the festival?" (the "Submission").

Use of any automated system to participate is prohibited and will result in disqualification. All Entries become the property of Sponsor and will not be returned or acknowledged.

7. **WINNER NOTIFICATION:** The potential winner will be notified via the email they provided at entry.
